


Charging and Fueling Infrastructure (CFI)

\$15 Million Award from the Federal Highway Administration under the CFI Community Program


Build additional charging stations on public sector property across 16-county region to fill gaps in existing regional charging network and achieve equal access to charging stations for everyone in the region


Procured Kimley-Horn and Associates, Inc. to serve as the "Deployment Dream Team" to expedite steps necessary for implementation

Promoted TxDOT Interactive Map and analyzed comments in or from our region


